

## ECSCA Rescue – Dog Rehoming Contract

This agreement, made between \_\_\_\_\_, (dog owner) and English Cocker Spaniel Club of America, Inc. (ECSCA) Rescue, allows ECSCA Rescue to rehome the owner's dog. The dog's owner agrees to allow ECSCA Rescue to rehome the dog through ECSCA Rescue channels. This includes (anonymously, if preferred) promoting the dog on the ECSCA website, ECSCA Rescue newsletter, and ECSCA Facebook page, as well as reviewing potential homes from the list of ECSCA Rescue applicants. In addition, should the dog be rehomed through ECSCA Rescue, the dog's current owner will donate the adoption fee (as determined by ECSCA Rescue adoption fee guidelines) to ECSCA Rescue.

- Up to 18 months: \$400
- 18 months to 8 years: \$350
- 8 years and up: \$200
- over 12 years old and/or special needs dogs (deaf, blind, serious medical problem) a donation of \$150 is suggested
