_____ I promise to allow any member of ECSCA Rescue access to this dog, by mutual prearrangement, and I will do nothing to obstruct placement of this dog in a home chosen by the ECSCA.

_____ I promise neither to release this dog to anyone else's care or ownership without the express permission and supervision of the ECSCA, nor to dispose of it in any way, including by sale, auction, impoundment or euthanasia.

_____ I will allow potential adopters access to view this dog at my home at mutually agreeable dates and times. Only people prescreened by the ECSCA may be considered. I understand that the ECSCA welcomes my input regarding suitable homes, but final decisions will be made by ECSCA.

_____ I will provide this dog with humane, reasonable and customary care and protect it from harm or neglect. I will keep the dog reasonably clean and groomed and continue any required medical care or treatment outlined above and/or attached to this document.

_____ I will incur the cost of general care and maintenance of this dog, including food, shelter, and grooming.

_____ Regarding veterinary care and costs, I agree to take this dog to a veterinarian for any pre-approved routine or emergency veterinary care that may be needed while under my care and as directed by ECSCA policy (ECSCA foster supervisor(s) will provide further details). I will relay the details and/or results of such care to ECSCA Rescue in a timely fashion. All such costs will be covered by the ECSCA unless a direct result of my negligence or malfeasance.

_____ I will get all non-emergency veterinary costs preauthorized by ECSCA and get emergency care preauthorized as soon as possible. (That is, do not delay emergency care while waiting for permission to treat but use common sense.) I will not self-diagnose or treat this dog without the supervision of a veterinarian or the approval of ECSCA.

_____ I agree to submit all documentation for pre-approved veterinary costs to Karen Spurlin, ECSCA club treasurer. Payment for all pre-approved veterinary and other expenses can be arranged directly with Karen Spurlin at 360-792-9120 or e-mail at auldsodecs@gmail.com. She can contact any facility ahead of time to arrange for direct payment by the ECSCA. Itemized copies of all bills must be mailed to Karen Spurlin at P.O. Box 760, Tracyton, WA 98393.

_____ I agree to foster this dog until a period of (amend if absolutely necessary) at least two weeks or until a suitable home is found and dog is transported there. This is usually no more than 3 months at the longest and often shorter. If I cannot hold this dog as long as necessary, I will give ECSCA as much notice as possible so that arrangements to move the dog can be made. If there is an emergency, the dog can be temporarily boarded at ECSCA's expense at an approved kennel or veterinary facility.

_____ I agree to prepare, complete and submit this document, as well as any other required ECSCA documents, to my Foster Coordinator.

_____ I agree to provide ongoing communication with my Foster Coordinator, via phone and email, to communicate foster dog general information, forms, medical updates etc.
